ORDINANCE NO. 2019-008

NO PARKING ORDINANCE: RENFAIRE DRIVE

AN ORDINANCE ESTABLISHING A "NO PARKING-TOW AWAY ZONE" ON RENFAIRE DRIVE WITHIN THE CITY OF TODD MISSION; AUTHORIZING AND DIRECTING THE PLACEMENT OF OFFICIAL SIGNS AND TRAFFIC CONTROL DEVICES NOTIFYING THE PUBLIC OF THE ZONES ESTABLISHED HEREBY; AND PROVIDING FOR THE FOLLOWING: FINDINGS OF FACT; AMENDMENT; REPEALER; SEVERABILITY; EFFECTIVE DATE; AND PROPER NOTICE AND MEETING.

WHEREAS, the City of Todd Mission has the authority under Section 311.002 of the Texas Transportation Code (the "Code") to regulate streets of the municipality and has the authority under Code Section 542.202 to regulate stopping, standing or parking of vehicles; and

WHEREAS, the City of Todd Mission desires to adopt an ordinance that will allow restrictions of parking on Renfaire Drive, demarcated by No Parking signs;

WHEREAS, the City of Todd Mission desires to adopt regulations under this Ordinance to restrict the parking on Renfaire Drive for the peace and order of the City and to protect the safety and welfare of pedestrians and the traveling public;

WHEREAS, the City of Todd Mission has determined that parking vehicles on Renfaire Drive presents a particular danger to the safety and welfare of pedestrians and the traveling public and believes it necessary and advisable to establish thereon a "No Parking-Tow Away Zone" through the use No Parking signs, as the City deems necessary and as is described in "Attachment A."

NOW, THEREFORE, BE IT ORDAINED by the City Council of Todd Mission, Texas:

1. FINDINGS OF FACT

The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein

2. NO PARKING ORDINANCE-RENFAlRE DRIVE

It shall be unlawful for any person to park or leave standing a motor-driven or motor-propelled vehicle in the area hereby designated and established as a no parking zone in *Attachment A*, which is attached hereto and incorporated into this Ordinance for all intents and purposes.

3. TRAFFIC-CONTROL SIGNS AND DEVICES

The City Council hereby orders and directs that parking signs and markings be placed on Renfaire Drive as deemed appropriate by city staff. The installation, placement, erection, and enforcement of parking signs and markings are hereby confirmed and ratified by the City Council.

4. REPEALER

All ordinances, resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance, are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.

4. SEVERABILITY

Should any of the clauses, sentences, paragraphs, sections or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.

5. CODIFICATION

The City Secretary is hereby directed to record and publish the attached rules, regulations and policies in the City's Code of Ordinances as authorized by Section 52.001 of the Texas Local Government Code.

6. EFFECTIVE DATE

This Ordinance shall be effective immediately upon passage.

7. PROPER NOTICE & MEETING

It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter

551. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.
